- The Educational agency shall submit the Annual Administration Report in the prescribed proforma as prescribed in G.O.Ms.No.1 Education, dated:01.01.1994, to the competent authority for every financial year by 30<sup>th</sup> of September at the latest. Such Report shall be supported by the audited statement of accounts of the school duly audited by a Chartered Accountant.
- The School Management shall upload their school information in the web site of the State School Education department including their fees details and other required information useful to the parents.
- The Management should follow the provisions of the Telangana Education Act, 1982; G.O.Ms.No.1, Education (PS.2) Department, dt:01.01.1994, as amended from time to time and Compulsory Teaching and Learning of Telugu as per the provisions of the Act No.10 of 2018, dt:30.03.2018, which came into force from 02.04.2018 and the connected Rules to this Act issued vide G.O.Ms.No.15, School Education (Prog.II) Department, dt:01.06.2018. The Government have also prescribed the books to be introduced for Classes I and VI which have to be followed for the Compulsory Teaching & Learning of Telugu language as per this Act 10 of 2018 & the connected Rules.
